**NOTICE OF INSURANCE INFORMATION PRACTICES**

THIS NOTICE IS PROVIDED BECAUSE WE ARE CONCERNED WITH YOUR PRIVACY AND THE INTEGRITY OF YOUR PERSONAL INFORMATION. We value your trust, and we want you to know about our practices for protecting the privacy of your non-public information which we receive in connection with our insurance products and services. **At no point will we intentionally disclose your information to individuals or entities other than strictly to support our insurance purposes on your behalf. We consider your business practices and personal information to be confidential and proprietary. This privileged status will remain intact even if our business relationship may end.**

We use a system of passwords, secured data storage and other appropriate physical, electronic and procedural safeguards designed to protect against unauthorized access to your nonpublic information contained in our records. Access to your information is restricted to those employees who need to know the information in order to provide products or services to you. We do relay appropriate information to affiliated third parties, including Insurance Companies and Finance Companies, in the course of our insurance services on your behalf.
